1. MAYOR'S OPENING COMMENTS:

The City of Orange City intends to adopt a budget and millage rate for Fiscal Year 2008/2009. The proposed millage rate is 4.48 mills which reflects a 5.71% decrease from the rollback rate of 4.7513 as provided by the Property Appraiser of Volusia County and does not reflect an increase in ad valorem taxes.
