**RESOLUTION NO. 659-11**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, PURSUANT TO SECTION 4.12 OF THE CITY CHARTER, CANVASSING THE VOTES AND DECLARING THE RESULTS OF THE RUNOFF ELECTION HELD IN THE CITY OF ORANGE CITY ON NOVEMBER 8, 2011; REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, a General Election was held in the City of Orange City on September 13, 2011; and

**WHEREAS**, the results of said election, as certified by Resolution No. 654-11, determined that none of the three candidates for Mayor of the City of Orange City received a majority of the votes cast, causing a runoff election as required by Section 4.03 of the City Charter; and

**WHEREAS**, the names of the top two candidates were presented to voters on ballots for the Runoff Election held on November 8, 2011; and

**WHEREAS**, pursuant to Section 4.12 of the City Charter, members of the City Council of the City of Orange City, Florida, not up for re-election, sitting as the Canvassing Board, on November 8, 2011, did canvass all votes cast in the Runoff Election held that date and certified the result as stated below.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:**

**SECTION 1.** That the following candidates for the office of Mayor of the City of Orange City received the following votes in the Runoff Election held in Precincts 303 and 309 on November 8, 2011:

That Tom Laputka is hereby declared the winner of the race for MAYOR of the City of Orange City.

**SECTION 4.** That all Resolutions or parts of resolutions in conflict herewith are hereby repealed.

**SECTION 5.** This Resolution shall become effective immediately upon its adoption by the City Council of the City of Orange City.
