**Subject:** Appointment to VGMC

**RESOLUTION NO. 640-11**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, REAPPOINTING ROBERT STORKE TO THE VOLUSIA GROWTH MANAGEMENT COMMISSION (VGMC); REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Volusia Growth Management Commission (VGMC) was formed by the Volusia County Council in 1987 following a public referendum that amended the County Charter in order to create the VGMC; and

**WHEREAS**, the purpose of the VGMC is to determine consistency between comprehensive plans for all of the governmental jurisdictions within Volusia County; and

**WHEREAS**, Section 202.3 of the Volusia County Charter states that there shall be one voting member from each municipality within the county and five voting members from the unincorporated area of the county. The appointment of each voting representative shall be made by the governing body of each jurisdiction; and

**WHEREAS**, it is necessary for the City Council of the City of Orange City to appoint a City representative to the VGMC; and

**WHEREAS**, Robert Storke has served on the VGMC since December 2009; and

**WHEREAS**, it is the desire of the City Council to reappoint Robert Storke as the City's representative on the VGMC.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:**

**SECTION 1.** That Robert Storke is hereby appointed to be Orange City's representative on the Volusia Growth Management Commission (VGMC) for a term commencing July 1, 2011 and to expire on June 30, 2014.

**SECTION 2.** That the individual named above in Section 1 shall have all of the powers, duties and responsibilities set forth in the rules and procedures of the Volusia Growth Management Commission.

**SECTION 3.** That all resolutions or parts of resolutions in conflict herewith are hereby repealed.

**SECTION 4.** That this resolution shall take effect immediately upon its adoption by the City Council of the City of Orange City, Florida.
