**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, PURSUANT TO SECTIONS 4.04 AND 4.05 OF THE CITY CHARTER LISTING CANDIDATES AND CERTIFYING THE FORM OF BALLOT FOR THE GENERAL ELECTION TO BE HELD ON SEPTEMBER 13, 2011, REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Sections 4.04 and 4.05 of the Charter of the City of Orange City, require that the City Council shall list candidates for Council Member and shall certify the form of ballot to the Supervisor of Elections; and,

**WHEREAS**, General and Run Off (if necessary) Elections were called for in Resolution No. 648-11 for Council Member District 1, 2, 3 and Mayor; and

**WHEREAS**, at the close of the legal qualifying period as identified in the City Charter and Resolution No. 648-11, the candidates listed below have fulfilled the requirements necessary to qualify to have their name placed on the ballot for the 2011 Orange City General Election:

**SECTION 1.** That the duly qualified candidates for the office of Orange City Mayor are as listed below:
