

**RESOLUTION NO. 567-09**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, PURSUANT TO SECTION 4.12 OF THE CITY CHARTER CANVASSING THE VOTES AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF ORANGE CITY ON SEPTEMBER 22, 2009; REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, A General Election was held on September 22, 2009 for Council Districts 4 and 5 and At-Large Council Member; and

**WHEREAS**, the Volusia County Supervisor of Elections provided the totals of all votes cast in Precincts #303 and #309 in the General Election; and

**WHEREAS**, pursuant to Section 4.12 of the City Charter, members of the City Council of the City of Orange City, Florida, sitting as a Canvassing Board on September 22, 2009, did canvass all votes cast in the General Election held this date.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:**

**SECTION 1.** That the following candidates for **COUNCIL DISTRICT 4** received the following votes in the General Election held in Precinct 303A on September 22, 2009:
