

RESOLUTION NO. 592-10

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, CONSISTENT WITH SECTION 2.2 OF THE CITY CODE, APPOINTING AN INTERIM CITY MANAGER FOR THE CITY OF ORANGE CITY; REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Interim City Manager Chester Murray's employment with the City of Orange City was terminated by the City Council on February 9, 2010 consistent with the City's Charter and Code of Ordinances; and

WHEREAS, the City Council is currently in the process of completing its search for a permanent City Manager; and

WHEREAS, the City Council wishes to appoint an Interim City Manager, consistent with the Charter and Section 2.2 of the code, to serve as the Chief Executive Officer of the City until the permanent City Manager is hired.

NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:

SECTION 1. The City Council hereby appoints

V. Eugene Miller as Interim City Manager.

SECTION 2. That the Interim City Manager is to serve from

February 12, 2010, 2010 until a permanent Manager is appointed by the City Council.

SECTION 3. That the Interim City Manager shall serve with all the authority, duties, and responsibilities as contained in the Charter and Code of Ordinances of the City of Orange City.

SECTION 4. The Interim City Manager will receive compensation as follows:

\$10,000 per month flat rate fee pro-rated
(on a per diem basis) for the duration
of service.

SECTION ~~4~~⁵. That all Resolutions or parts of Resolutions in conflict herewith be and the same are hereby repealed.

SECTION ~~5~~⁶. That this Resolution shall take effect upon the full execution of an employment agreement by the Mayor of Orange City and the Interim City Manager.
